Please note the following:

- * The heirship affidavit must be signed by someone who was well acquainted with the deceased **but who is NOT an heir to the Estate.**
- * Fill out the affidavit as completely as possible and type or print clearly.
- * Have the affidavit notarized.
- * You may wish to record the heirship affidavit in the County and State where the property is located. This is not a requirement for our purposes.
