Pipeline Loss Allowance: One-tenth of one percent (0.1 of 1%) of all volumes of refined products that are moved under this joint tariff rate shall be deducted from such volumes and shall be retained by Enterprise TE to cover losses due to shrinkage and evaporation incident to transportation on MPL’s and Enterprise TE’s facilities, and the volumes delivered to the shipper shall be net of such deduction.		
Ancillary Charges: Any ancillary charges and/or any other applicable fees (any fees outside of the transportation rate to be charged above) that would be charged under the MPL Rules and/or the Enterprise TE Rules respectively, shall be payable by the shipper to the respective carrier.
